3. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.
4. Release, waive, discharge and covenant not to sue the KI/MMA, its affiliated clubs, organizations, their respective administrators, directors, agents, coaches, and other employees or volunteers of the KI/MMA, organization, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used, all of which are hereinafter referred to as "releasees" from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise,

The undersigned understands that during the course of training, employees of KI/MMA, and/or other students or authorized personnel will be engaged in a course of conduct that can require extensive physical contact.
